AFFIDAVIT, RULES & REGULATIONS FOR BOARDERS/RESIDENTS

Affidavit/Undertaking

liabilities during my stay at hostel of	of MTI-GKMC Swabi, and in case	of violation of any of the clause or clauses
shall expose me to the legal proce	eeding under the Rules and shall b	be expelled/ejected from the Hostel, if the
authorities deem it appropriate.		

- 1. No student will be allowed to change room once allotted to her except with prior permission of warden. Student doing their mutual shifting without permission of the hostel warden or assistant provost will be fined Rs: 5000each.
- 2. That narcotic activity of any nature either directly or indirectly is strictly prohibited.
- 3. That boarder/resident shall not become party to any procession of agitation or protest.
- 4. Guest are not allowed for night stay in hostel, provided that if someone unavoidable circumstances appear, will get permission from the competent authority.
- 5. Resident students are not allowed to participate in any political activity. They are not allowed to invite any political figure/ individual/ scholar for any speech/ lecture/ sermon etc.
- 6. No student is allowed to smoke, play cards or gamble in the hostel premises.
- 7. Entry of females in to boys hostels and vice versa is strickly prohibited.
- 8. Resident students are not allowed to use, heater, air coolers, air conditioners, T.Vetc. in their rooms. Any violation will lead to imposition of fine, recovery of charges incurred and confiscation of the forbidden item
- 9. Resident students are not allowed to keep any valuables, arms, intoxicants, drugs; rods are daggers, and harmful material etc. in the hostels. Any violation of this rules will resulting serious disciplinary proceeding and may lead to imposition of heavy fines and expulsion from the hostels.
- 10. The warden and assistant warden or any others college authority shall not be responsible for the loss or theft of any personal belonging i.e. (laptop, mobile phones, cash) etc.
